

**JIA Foundation 2023 FAMILY RINKAN-GAKKOU-family overnight camp  
Waiver and Release**

This Waiver and Release relates to the undersigned Participant's participation in the 2023 JIA Foundation Family Summer Camp, hosted by the JIA Foundation, a Washington non-profit corporation from August 19, 2023 through August 20, 2023 ("Rinkan Gakkou"). If Participant is under the age of eighteen (18), then this Waiver and Release must be reviewed and signed by Participant's parent or legal guardian ("Guardian"). For and in consideration of Participant's being allowed to participate in Rinkan Gakkou, Participant/Guardian agrees to all of the following:

1. I understand that Rinkan Gakkou may exclude Participant/Guardian in the event that I or my child(ren) fail to abide by Rinkan Gakkou's health and safety protocols, disrupt, impede or interfere with the operations of Rinkan Gakkou, or threaten the health, safety or welfare of other participants or Rinkan Gakkou staff, and that no refund of any fees will be made in such circumstances.
2. Participation in any program which involves physical activity exposes the camper to certain risks and dangers. Accidents and injuries are always a possibility, and it is impossible to foresee and protect the camper from all conceivable dangers. Participant/Guardian hereby acknowledges the risks and dangers associated with Participant's participation in Rinkan Gakkou, which include in part, injury and/or damages to persons or property, serious bodily injury and death. Participant/Guardian voluntarily and knowingly assumes and accepts any of such risks and dangers of injury or death to Participant.
3. Participant/Guardian agrees to forever RELEASE, DISCHARGE, INDEMNIFY, PROMISE NOT TO SUE AND TO SAVE AND HOLD HARMLESS JIA FOUNDATION and its officers, directors, volunteers, insurers, contractors and agents from any loss, liability, damage, or costs whatsoever arising out of or related to any loss, damage, or injury (including death) to Participant arising out of or in any way connected with Participant's participation in Rinkan Gakkou. I further agree that if any such claim is made, I will indemnify and defend the foregoing parties with respect to any such claim, injury or damage.
4. This Waiver and Release is governed by the laws of the state of Washington, and is intended to be as broad and inclusive as is permitted by such law, and that, in the event any portion thereof is held invalid, it is agreed that the balance shall continue in full legal force and effect.
5. Participant/Guardian grants to JIA Foundation the right to use, without any cost, Participant's name, likeness, and image, in print, video, or electronic media form, but only in promotional materials or any account or record of Participant's participation in activities sponsored or promoted by JIA Foundation.

**PARTICIPANT/GUARDIAN HAS READ THIS DOCUMENT AND AGREES TO ALL OF ITS TERMS. PARTICIPANT/GUARDIAN UNDERSTANDS IT IS A LEGALLY BINDING AGREEMENT AND WAIVES CERTAIN LEGAL RIGHTS OF PARTICIPANT, INCLUDING, BUT NOT LIMITED TO A RELEASE, WAIVER, PROMISE NOT TO SUE AND A HOLD HARMLESS FOR ALL CLAIMS. THIS AGREEMENT SHALL BE BINDING UPON PARTICIPANT/GUARDIAN AND PARTICIPANT'S ESTATE, SUCCESSORS AND ASSIGNS.**
